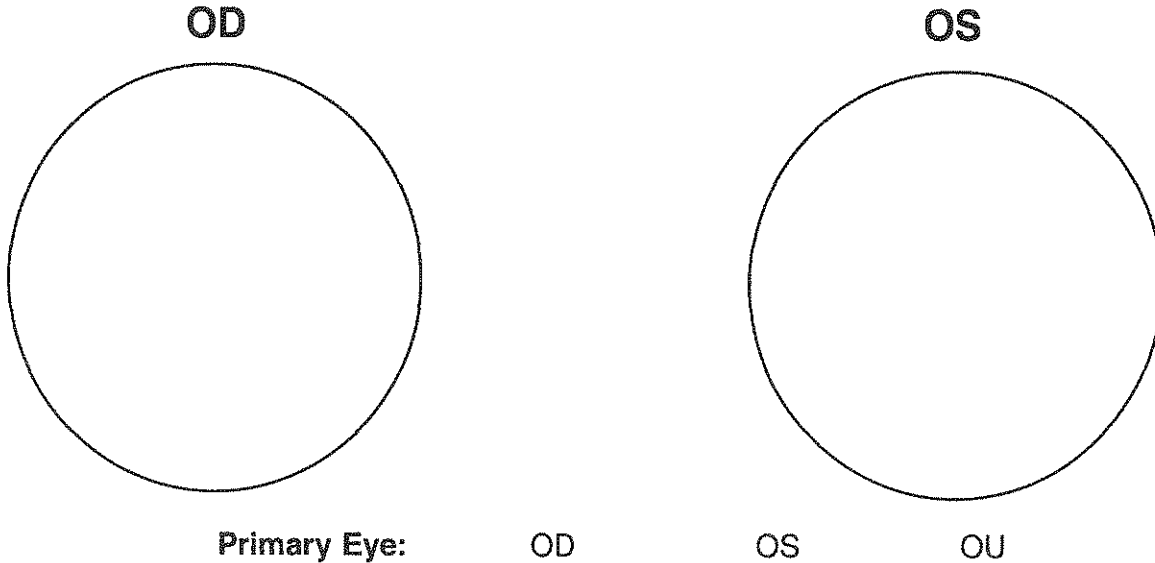

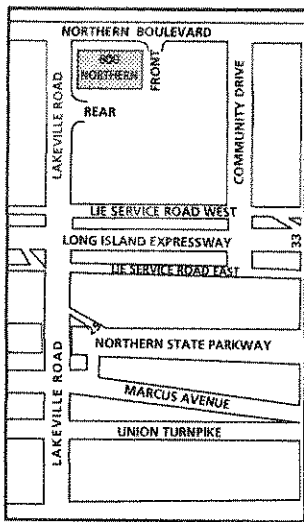

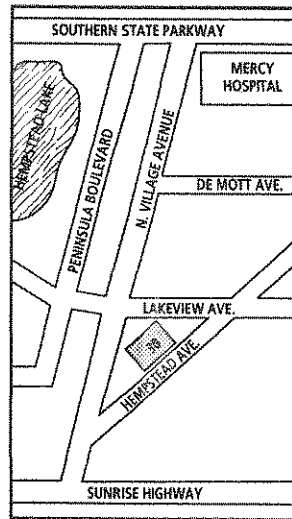

NORTHERN STATE: Exit 25N to Lakeville Road and follow instructions above.



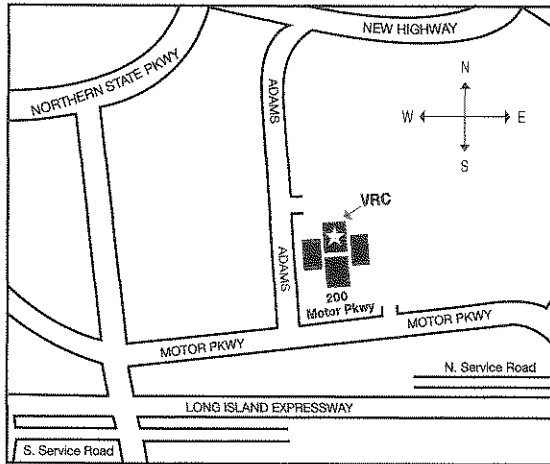

SOUTHERN STATE PARKWAY: (East or West Bound) to Peninsula Blvd. Southbound - go past Mercy Hospital on Peninsula Blvd. for approximately 1.8 miles to Lakeview Avenue. At traffic light make left turn onto Lakeview Avenue. Travel for 4 blocks to Hempstead Ave. - right turn on Hempstead Avenue to our office. Ample parking in rear.

SUNRISE HIGHWAY - North on North Village Ave. to 1st Traffic light after RR tracks. Bear right onto Hempstead Ave. (bldg. on left).



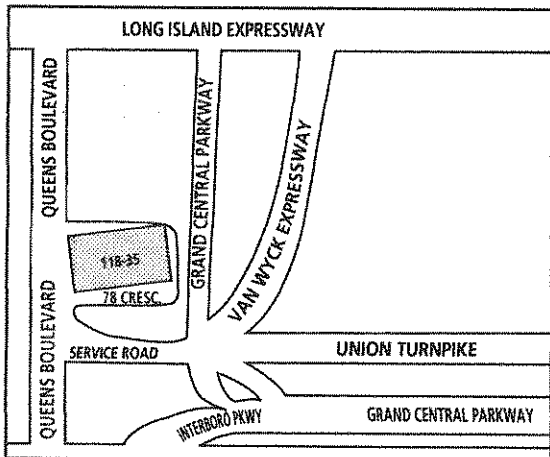

From the East: Heading west on the LIE, take Exit 55. Stay on service road. Make a right onto Motor Parkway (County Road 67). Take Motor Parkway for about a mile. Turn right into parking lot of 200 Motor Parkway. Park in the back of the complex, near Building A.

From the West: Heading east on the LIE, take Exit 53. Stay on service road. Follow exit ramp to Wicks Road. Make left onto Wicks Road. Make first right onto Motor Parkway (County Road 67). Turn left onto Adams Avenue, then first right into parking lot of 200 Motor Parkway. Park near Building A

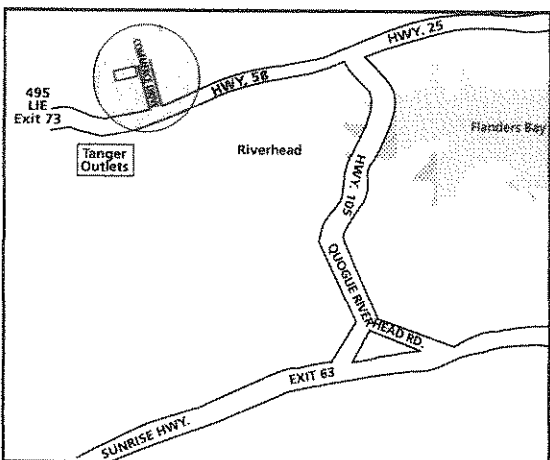

FROM LIE: Take the LIE east to the very end, exit 73, and continue onto route 58. One half mile turn left into Commerce Drive. Building on left side #47.

FROM THE NORTH FORK: Take Route 25 west into Old Country Road (Route 58). Turn right into Commerce Drive. Building on left side #47.

FROM THE SOUTH FORK: Take Sunrise Highway to exit 64 north, Quogue Road (Route 104). Continue north to Route 105. Take Route 105 to Route 25. Left on Route 25. Stay straight onto Route 58 (1/8 mile). Continue on Route 58 through the traffic circle. Continue for 1.4 miles on Route 58 to Commerce Drive. Turn right into Commerce Drive. Building on left side #47.
